PRESIDENT GOODEN reminded everyone to stay up on the text of the proposed equal rights amendment. President Gooden said that we need to be aware and vote.

Proposed NYS Equal

Rights Amendment:

No person shall be denied the equal protection of the laws of this state or any subdivision thereof. No person shall, because of race, color, ethnicity, national origin, age, disability, creed [orl, religion, or sex, including sexual orientation, gender identity, gender expression, pregnancy, pregnancy outcomes, and reproductive healthcare and autonomy, be subjected to any discrimination in his or her] their civil rights by any other person or by any firm, corporation, or institution, or by the state or any agency or subdivision of the state, pursuant to law.

Nothing in this section shall invalidate or prevent the adoption of any law, regulation, program, or practice that is designed to prevent or dismantle discrimination on the basis of a characteristic listed in this section, nor shall any characteristic listed in this section be interpreted to interfere with, limit, or deny the civil rights of any person based upon any other characteristic identified in this section.

This amendment was passed by two separate sessions of the NYS Legislature and now goes to the voters for their approval on Election Day 2024.

NAACP Meeting Student Report February 1, 2024 Jakob Pregent, Glens Falls HS Senior • Black History Month: Students are being encouraged to attend the movies scheduled for Tuesday nights at Crandall Library. • Selma: Plans were being made for an 11th grade assembly to show the movie Selma. Members of the branch will be invited to attend and participate in a discussion afterwards. The January NYS Regents essay for US History was about the history of African American voting. • Celebrating the Diversity in our School Community: Several high school students attended a community outreach event on January 11th at 6:30PM. With the help of Mediation Matters, several seniors had a fantastic time! They really enjoyed meeting community members and sharing their stories and perspectives about diversity in the Glens Falls High School and the Glens Falls community. They left demanding we have an opportunity to share this experience with all high school students. Another evening community event is planned for the spring. • New York State's Dignity for All Students Act (The Dignity Act) and Youth Homelessness Hotline Students traveled to the NYS Assembly and were afforded almost 1.5 hours with Assemblywoman Carrie Woerner and Assemblyperson Daniel O'Donnell. This is quite remarkable considering the Assembly is in session. The discussions ranged from unattended homeless youth hotline to bullying and a new version of DASA, married equality and overall the lawmaking process. Students did an exceptional job answering grilling questions about their DASA survey results of Lake George and Glens Falls High School students. IN session the students were recognized and complimented for their service to NYS youth. Several other Assembly representatives came to meet them and ask to be part of the

DASA revisited project. Assemblywoman Woerner also agreed to propose a bill this session to allocate money from the additional homelessness budget

to include money for the hotline. GFHS student Jack Sweet continues to push for this bill to be completed and passed. He is working with the Governor's Youth Council and lobbyists to gain some traction. DASA Survey Results Hand out ● "STOP" Field Trip Jan 12 Several GF Middle School students attended this field trip to Siena College. This year, the theme was The Legacy of Bayard Rustin, where they explored Rustin's organization of the March on Washington, contemporary Black and LGBTQIA+ activism, and engaged in anti-bias workshops with students and educators across Upstate NY. • Black Girl in Suburbia- March The 10th grade class will be having an assembly showing "Black Girl in Suburbia" with a student-led discussion afterwards. This assembly has been pushed to March to allow for more training. The planning for this is underway! • Community Climate Action Walk, City Park to Crandall Park, Glens Falls, Saturday, May 18, 2024 1 PM. High school students are busy recruiting and organizing ways to participate. Students are busy planning their role in this event. • Innocence Project Event: Glens Falls Government (Ms. Gormley) & Forensic Classes (Mrs. Ludlow) are working on a plan to bring back a guest speaker who has visited twice prior to the pandemic. Mr. Everston Wagstaffe is a man who was a young Jamaican immigrant when he was arrested and sent to prison for a murder he did not commit. • Coffee with a Cop Many students are very interested to attend the future meeting to be a part of the "Coffee with a Cop"
